

HONDA WINTER SYSTEM SAFETY CHECK PRIZE DRAW – 2010

Terms & Conditions

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.

2. Entry is only open to Australian residents aged 18 years or over and undertake the Winter Safety Systems Check at an authorised Honda dealer.

3. Employees (and their immediate families) of the Promoter, or Honda Motor Vehicle dealerships and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

4. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

5. Incomplete, indecipherable, or illegible entries will be deemed invalid.

be deemed invalid, and only the first unique entry is permitted.

7. To claim the prizes, entrants must provide proof of purchase by retaining their Original Repair Order Invoice. Failure to produce the proof of purchase when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of an entrant's entries and forfeiture of any right to a prize.
